Research: With the support of charitable contributions from foundations and corporations, MCN studies nonprofit sector trends and shares this research with members, other nonprofits, decision-makers and the media. In 2018, MCN shared information widely on Minnesota's nonprofit sector, demonstrating the economic impact of nonprofits on the state's economy. MCN also conducts nonpartisan research and analysis on tax, budget, and economic issues through the Minnesota Budget Project. The Minnesota Budget Project's analysis particularly focuses on how policy choices and economic trends impact low- and moderate-income Minnesotans and communities of color, expansion of economic opportunity in Minnesota, the contributions of Minnesota's immigrants to the economy and local communities, and relative progress toward a fair and sustainable tax system.

Advocacy: MCN undertakes in advocacy efforts to strengthen the nonprofit sector and its ability to serve communities throughout Minnesota. MCN's major state-level advocacy efforts in 2018 were introducing a proposal to expand the sales tax exemption to more nonprofits; bringing the nonprofit employer perspective to the policy debate about workforce issues, including the minimum wage ordinance development in St. Paul; and opposing the expansion of city fees levied on charitable nonprofits exempt from property tax. MCN's Minnesota Budget Project identifies and advances public policies that expand economic opportunity and prosperity, especially in the areas of state tax, budget, and economic policy. The Minnesota Budget Project focused
